3. HAZARDOUS IDENTIFICATION:

Inhalation: It inhaled, move to fresh air- If not breathing, and give artificial respiration. If difficulty breathing, give oxygen.

Ingestion: If ingested, immediately call a physician.

5. FIRE FIGHTING MEASURES:

Extinguishing media: Water spray / Fog CO2 foam; Dry chemical.

Special firefighting procedures: Wear protective gear and self-contained breathing apparatus. Foam may cause frothing.

Special fire and explosion hazards: May produce at high temperatures, acrolein and fluoride vapors/gases.

Heavy spore may travel along ground and cause flash back

Personal precautions: Wear protective clothing to prevent contact with skin and eyes. Environmental precautions: Follow all applicable local disposal regulations

7. PRECAUTIONS AGAINST FIRE AND EXPLOSION:

8. PRECAUTIONS DURING HANDLING & STORAGE:

Handling: keep container tightly closed. Use in property ventilated areas.

Storage: store away from heat in dry area. Do not mix with other chemical solutions

Respiratory precautions: Single dental patient use in properly ventilated area / room should not necessitate use of respirators. If unsure of exposure or for other exposures. select a respirator suitable for mist / vapors.

Hand protection: Wear protective gloves

Eye protection: Wear safety glasses; splash goggles as usage requires.

Skin protection: Wear as required for dental patient care.

Specific hygienic practices: Avoid breathing vapors. Avoid eye and skin contact Wash thoroughly after handling. Wash clothing if contact with solution
